



## Scope and Level of Collective Bargaining Agreement



For workers Law No. 6356	For civil servants Law No. 4688
Workplace or enterprise level	Sectoral or national level
Group collective bargaining agreement	Service branches
Cover trade union member workers (Solidarity Fee)	Cover all civil servants

Law No. 6356

1-3 Years

For civil servants
Law No. 4688

2 years

The vast majority of CBAs, which annotated through the Cobra System, are for 2 years.

- Trade union with the highest number of members






## Turkish WageIndicator CBA Database





There is no significant difference between the renewed CBA and the expired CBA in terms of the provisions





14 of these CBAs belong to private sector and 14 of them belong to public and semi-public.

11 of these CBAs were signed after 2020.

8 belong to the energy sector

5 to transportation, 9 to Commerce Bureau Education, 3 to general industry

1 to metal, 1 to food industry and 1 to communication sector











## JOB DESCRIPTION OR JOB CLASSIFICATION SYSTEM

- 11 OF 28 CBAS INCLUDE
- JOB DESCRIPTION WAS INCLUDED IN ONLY ONE CBA
- JOB CLASSIFICATION WAS INCLUDED IN 10 CBAS



## TRAINING AND APPRENTICESHIP

- 16 OF 28 CBAS INCLUDE
- TRAINING IN ALL OF THE 16 CBAS
- ONLY 7 OF THEM MENTIONED APPRENTICESHIP



#### TRIAL PERIOD


- 27 OF 28 CBAS INCLUDE A TRIAL PERIOD
- 2-4 MONTHS
- 3 OF THESE CBAS HAD A TRİAL PERİOD OF 120 DAYS, 9 OF THEM 30 DAYS, 5 OF THEM 60 DAYS AND 10 OF THEM 90 DAYS OF TRİAL PERİOD.











Employer's contribution regarding health insurance


Note: Considering the legal framework regarding working life and the right to social security in Turkey, it should be underlined that all insured workers are covered by health insurance.

In case of working on Sundays, premium is given in 13 CBAs






